

PEACE21: CYCLE FOR PEACE

Rules & Regulations

General

1. “PEACE 21: Cycle For Peace” is a virtual cycling event.
2. The event will be held from 21 Sept to 11 Oct 2021.
3. The goal is to cycle the circumference of the world collectively (approx. 40,075km).
4. Participants may cycle at any location to accumulate the total distance. Please adhere to the SOP of the National Recovery Plan based on your locality.
5. Minimum requirement to obtain the finisher e-certificate is 21km. Distance can be accumulated in multiple rides throughout the event period.

Registration

1. Registration is open to everyone residing in Malaysia, aged 13-year-old and above only.
2. Register here: harmonico.my/peace21
3. Registration Period: 11 Sept – 11 Oct 2021
Ride Period: 21 Sept – 11 Oct 2021
4. Registration fee is rm30.00/pax
5. Registered participant will receive the following via postage:
Jersey, tote bag, lanyard, participant card (individual unique number), peace cards, vouchers
6. Postage to West Malaysia is free, while rm10 postage fee will be charged to East Malaysia.

Results

1. Results shall be uploaded with the screenshot of the ride records on a suitable tracking app. (Eg. Strava, Zwift) to Howei’s platform, as per registration.
2. All ride records must display: Date, Duration and Distance.
3. Static cycling machines are allowed, as long as the Date, Duration and Distance can be captured on the machine.
4. Results can be uploaded in multiple entries to accumulate total distance. Only participant’s own results shall be uploaded.
5. Ride for 21km and above to be eligible for Finisher’s E-Cert.
6. Only rides recorded from 21 Sept – 11 Oct 2021 are valid.

Competition

1. There will be 2 competitions ongoing:
 - The PEACE Champion Award - For most distance covered (Men’s and Women’s category)
 - The PEACE Maker Award - For best photos and captions
2. Only registered participants of PEACE21 are eligible to participate.

Lucky Draw

1. Participants who cycle 21km and above per week will be eligible for a lucky draw.
2. Lucky draw dates will be on 28 Sept, 5 Oct and 12 Oct 2021.
3. Each draw will have 7 lucky winners.

COMPETITIONS

THE PEACE CHAMPION AWARD - For Most Distance Covered

- a. Cycle the most distance among all participants in respective category and win prizes.
- b. Upload results as per all participants. Distance can be accumulated in multiple rides throughout the competition period. Please upload results no more than 7 days upon completion of each ride.
- c. Upload a selfie after completion of every ride with participant card (display individual unique number) to be eligible for Most Distance competition.
- d. Various verification will be carried out. The organiser reserves final discretion on the result authenticity.
- e. Winners will be announced after 11 Oct 2021.
- f. Prizes for winners of each category (men's & women's) are as follow:
 - 1st – RM 500 TNG E-wallet credit
 - 2nd – RM 400 TNG E-wallet credit
 - 3rd – RM 300 TNG E-wallet credit
 - 4th – RM 200 TNG E-wallet credit
 - 5th – RM 100 TNG E-wallet credit

THE PEACEMAKER AWARD – For Best Photo & Caption, presented by DoGood

- a. Post a photo on your Instagram feed that best represents PEACE in your own creative way, and tell us what PEACE means to you in the caption.
- b. Tag @harmonico.my and @dogoodmy, hashtag #peace21 #peacemaker
- c. Make sure your account is set to public throughout the duration of the competition.
- d. Winners will be announced after 11 Oct 2021.
- e. Prizes for winners are as follow:
